1. Introduction

Our website, <https://www.cathrinhagey.com> (hereinafter: "the website") uses cookies and other related technologies (for convenience all technologies are referred to as "cookies"). 2. What are cookies?

3. What are scripts?

4. What is a web beacon?

A web beacon (or a pixel tag) is a small, invisible piece of text or image on a website that is used to monitor traffic on a website. In order to do this, various data about you is stored using web beacons.

5.1 Technical or functional cookies
